The Buyer represents, warrants and undertakes that:

- it will not sell, export, re-export, transfer, supply or deliver the vehicle(s), directly or indirectly, to any country, territory, person or entity that is the target of restrictive measures (sanctions) of the European Union, the United Nations, the United States or the United Kingdom;
- where it resells or transfers the vehicle(s), it will impose an equivalent written prohibition on re-export to Russia and Belarus on each subsequent purchaser, including an obligation on that purchaser to pass the same prohibition further down the supply chain (cascade clause);
- neither the Buyer, nor any of its beneficial owners or controlling persons, is a designated / sanctioned person, and the Buyer is not owned or controlled, directly or indirectly, as to 50% or more, by any such person;
- it will, on the Supplier's request, provide documentary evidence of the final destination of the vehicle(s) (including import, customs, registration or CMR documents); and
- it will promptly inform the Supplier of any circumstance that would render any statement in this declaration inaccurate.

5. Consequences of breach

Any breach of this declaration entitles the Supplier to suspend or terminate the supply, to claim damages and any penalties agreed in the underlying contract, and to withhold or void warranty support. The Supplier may report suspected breaches to the competent national authorities. This declaration survives delivery of the vehicle(s).
